[PROPOSED] ORDER

On October 27, 2016, Plaintiff Wendy Huang in her capacity as Trustee of the Guo/Huang Family Trust ("Plaintiff") and Defendant Benjamin Kirk ("Defendant") (collectively, the "Parties"), filed a Stipulation and Proposed Order Re Plaintiff's Motion For Partial Summary Judgment (Docket No. 130) and Defendant's Rule 56(d) Motion (Dkt No. 137). Docket No. 146.

Pursuant to the Stipulation of the Parties, and good cause appearing, Plaintiff's Motion for Partial Summary Judgment (Docket No. 130) is hereby **GRANTED** on the issue of liability.
