I, **A. Redmond Doms**, declare:

1. I am a Petitioner/Plaintiff in this matter and I make this declaration in support of the Petition for Writ of Mandate and Complaint for Injunctive and Declaratory Relief regarding the planned sale of eleven state-owned office building complexes.

2. I am a taxpayer of the state of California, and a resident of Los Angeles County. I have paid taxes in the state of California for many years, and certainly in excess of the one year required by Code of Civil Procedure § 526a.

3. For many years I served on the Los Angeles State Building Authority (the "Authority") – a three-person body established to plan, finance and oversee the construction and management of state office facilities in downtown Los Angeles. Two members of the authority are appointed by the governor; the third is appointed by the Los Angeles Community Redevelopment Agency. There are similar entities in other California cities.

4. I was summarily dismissed earlier this year by the governor.

5. Neither I nor my colleagues were consulted prior to passage of ABX4 22, despite the fact that the legislation directly affects government office buildings in Los Angeles that fall under the jurisdiction of the Authority. Upon information and belief, none of the other building authorities (such as in San Francisco and Oakland) were consulted either.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct, and that this declaration was executed in Van Nuys, CA California on November 15, 2010
