COTCHETT, PITRE & McCARTHY LEADS LAWSUIT AGAINST WELLS FARGO DIRECTORS AND OFFICERS FOR THEIR MISCONDUCT AND TO CLAW-BACK THEIR BONUSES

WELLS FARGO DIRECTORS AND OFFICERS FOR THEIR OPENING PHONEY ACCOUNTS TO DEFRAUD CUSTOMERS

CPM represents Wells Fargo shareholders in a lawsuit filed in San Francisco County Superior Court on behalf of the Company, and against Wells Fargo officers and directors, over the creation of over **2 million phony accounts** and charging unknowing customers unwarranted fees. The complaint alleges that Wells Fargo's senior management allowed the bank to commit a major fraud on consumers resulting in serious harm to the bank. In September 2016, the Consumer Financial Protection Bureau (CFPB) fined Wells Fargo Bank \$100 million for unlawful sales practices, the largest penalty ever imposed by the CFPB. The CFPB said that Wells Fargo employees, for years, were pressured to secretly open unauthorized accounts to meet sales targets and allow executives to receive bonuses. The suit is requesting a claw-back or return of all bonuses paid to officers and directors including CEO John Stumpf. The case is being led by **Joe Cotchett, Mark Molumphy, Nancy Fineman, Alexandra Summer** and **Stephanie Biehl**. Many customers equate the conduct by Wells Fargo's officers to "identity theft" and many are asking for personnel to be prosecuted for criminal conduct. The United States Department of Justice is now looking at this.



Exploding Samsung Smartphones Across the Country

The recent recall of Samsung Galaxy Note 7 phones due to the safety risk of overheating and in some instances exploding, is just the tip of the iceberg. **CPM** along with Stonebarger Law have filed suit against Samsung for defects in

its Galaxy 6S Active phone, which exploded due to overheating and caused serious injuries to consumers. CPM's investigations raises serious questions about Samsung's prior knowledge of the risk of overheating and explosion in prior generations of its phones which were concealed from the public. Those earlier versions have not been recalled. CPM attorneys **Frank Pitre**, **Alison Cordova and team** re handling the case.



Lead Poisoning in Water Fresno, California

In what may become another Flint, Michigan situation, many residents of Fresno have been exposed to greatly

elevated levels of lead. **CPM** has been asked to investigate the distribution of drinking water containing lead above threshold levels to residents of Northeast Fresno. **Frank Pitre, Julie Fieber and team** of CPM are leading the investigation.

Shareholders Sue Alibaba for Initial Public Offerings
- San Mateo County Superior Court -



CPM represents purchasers of Alibaba's initial public offering of \$25 Billion. Alibaba is the world's largest international trade site located in China with U.S. headquarters in San Mateo. Soon after

the IPO was completed, the company revealed that Chinese regulators conducted meetings with Alibaba about sales abuses of counterfeits just prior to the IPO. This resulted in a massive stock drop. CPM has been appointed Co-Lead Counsel with **Mark Molumphy**, **Alexandra Summer**, **Stephanie Biehl and team** handling the case.



CPM is Named Co-Lead Counsel in Suit Filed for Generic Drug Price Manipulation of Digoxin and Doxycycline - Philadelphia - U.S. District Court -

CPM's attorneys Steve Williams, Adam Zapala, Joyce Chang and team recently filed complaints on behalf of consumers who purchased generic doxycycline and/or generic digoxin from defendants. Plaintiffs allege that defendants conspired to unlawfully raise the prices of generic doxycycline and generic digoxin to supracompetitive levels—thereby injuring consumers and members of the Indirect Purchaser Classes.

Cutting Edge Privacy Case - Los Angeles - U.S. District Court -



CPM has filed a cutting edge privacy act technology case *In re Vizio, Inc., Consumer Privacy Litigation*. The complaint alleges that Vizio - a smart TV manufacturer - installed tracking software that permits it to track, collect and disclose consumers' viewing habits to third-

parties for profit without adequate disclosures to consumers. The CPM team prosecuting the case is lead by **Joe Cotchett**, **Adam Zapala and team**. Judge Josephine Staton appointed CPM as co-lead counsel to proceed with the litigation.

CPM is Fighting California's Water Wars City of Weed - Mt. Shasta Water

CPM filed a class action lawsuit on behalf of the citizens of the City of Weed against Roseburg Forest Products. For the past 50 years, Roseburg charged the City \$1 a year for use of water from the Beaughan Spring. As of July, it began charging \$97,500 annually. A contract signed this year also directs the City to look for alternative sources. Based on news articles, Roseburg is selling the water to Crystal Geyser Alpine Spring, which bottles it in Weed and ships it as far away as Japan. Crystal Geyser is looking to increase its overall supply. Residents of Weed, including the current mayor and three former mayors, say the water was always intended for municipal and domestic use and should not be sold to the highest bidder. **Phil Gregory, Brian Danitz and team** are handling this case.



CPM Files Lawsuit Against Hyperloop for Retaliation Against Employees - Los Angeles County Superior Court -

CPM represents former employees of Hyperloop One, a Los Angeles-based corporation that is developing a new 21st century transportation system designed to move passengers and cargo in a fast, safe and energy efficient manner. CPM's clients allege they were ousted from Hyperloop after they expressed concerns about the company's mismanagement and breaches of fiduciary duty. The case is being handled by CPM attorney **Justin Berger** and paralegal **Valerie De Los Santos.**

CPM Sues Alleging Price-Fixing in Poultry Products - Illinois - U.S. District Court -



CPM filed a complaint in Illinois on behalf of consumer purchasers of Broilers (chickens) alleging that defendants conspired and combined to fix the prices of poultry in the United States. Broil-

ers constitute approximately 98% of all chicken meat sold in the United States. Defendants are the leading suppliers of Broilers in an industry with over \$30 billion in annual wholesale revenue. **Steve Williams**, **Adam Zapala and team** are handling the case.

Samsung-LG Anti-Poaching Agreement - San Francisco - U.S. District Court -



CPM filed a complaint against Samsung and LG alleging that the top executives at these companies secretly agreed to collectively deprive thou-

sands of their employees of higher compensation and better benefits, as well as deny them opportunities to advance their professional careers at a competitor, by refusing to hire each other's employees. CPM's **Steve Williams**, **Adam Zapala**, **Elizabeth Tran and team** are leading the litigation.



FALSE CLAIMS & ELDER ABUSE UPDATES



Settlement in Whistleblower Lawsuit Against Beauty School Chain - Los Angeles - U.S. District Court -

CPM's Justin Berger and Eric Buescher settled a False Claims Act case against Marinello Schools of Beauty for several million. The case was filed in 2013 on behalf of the United States by six whistleblowers, former employees of Marinello. Based on overlapping allegations, on February 1, 2016, the United States Department of Education

denied Marinello's application to requalify its campuses to receive federal student loan funds, forcing Marinello to close its doors. Prior to its closure, Marinello was one of the largest chains of for-profit beauty schools in the United States. The lawsuit alleged that Marinello and four of its executives engaged in six broad schemes to induce students to enroll in the school, and to improperly receive federal student loan funds. The case settled three months before the start of trial in the United States District Court for the Central District of California. CPM handled the case with co-counsel Geralyn Skapik, Eric Morris, and John Graham.

Case Against BP for Overcharging the State of California - San Francisco County Superior Court -

Nationwide depositions are ongoing in **CPM's** case against oil company BP for overcharging the State of California on purchases of natural gas. California Attorney General's office joined the case last year. CPM attorneys Niall McCarthy and Justin Berger lead a large team along with Houston-based co-counsel are working closely with the Attorney General's office to push the case towards trial. The case alleges that BP overcharged state, county, and local governments on hundreds of millions of dollars in natural gas purchases.

War Veteran Seeks Justice in Elder Abuse Case Against Nursing Facility - Los Angeles County Superior Court -

CPM represents George W. Willis, an 88 year old veteran of the Korean War, in an elder abuse case against Culver West, a skilled nursing facility ("SNF") in Los Angeles. As alleged in the complaint, while at Culver West, Willis suffered from terrible neglect and abuse. He developed a pressure ulcer which extended to his bone (his bone can be seen through the wound), as well as a neck abscess, among other conditions. The case was filed under California's Elder Abuse Act which protects our State's seniors from physical abuse and neglect, as well as financial abuse. CPM attorneys Anne Marie Murphy, Eric Buescher and paralegal Valerie De Los Santos are handling the case.

Senior Citizens Battle Against High End Campus Retirement Village for "Up-Streaming" \$190 Million - San Jose - U.S. District Court -

CPM is pursuing an action on behalf of the residents of the Vi-Palo Alto, a Continuing Care Retirement Community (CCRC). CPM's clients are a retired Nobel Prize winner, doctor, World War II journalist and a unique collection of accomplished South Bay senior citizens. The lawsuit is believed to the first of its kind in the Bay Area challenging a CCRC's financial practices. The complaint alleges that millions of dollars were "up-streamed" from the Palo Alto facility to its corporate parent in Chicago, leaving the senior citizen residents financially vulnerable. CPM attorneys Niall McCarthy, Anne Marie Murphy and paralegals Darren Kelley and Megan Nash are handling this case.

Settlement with ProSolutions, a Debt Collection Company - San Francisco - U.S. District Court -

CPM has reached a proposed class action settlement with debt collection company ProSolutions. The action alleged that ProSolutions participates in unlawful debt collection practices in violation of federal and California law. The proposed settlement provides for: 1) substantial changes



in ProSolutions' practices and procedures; 2) 40% debt relief to Class Members with open accounts; and 3) a cash settlement fund. Through the settlement, ProSolutions has agreed to change essentially all of its business practices that gave rise to the litigation. The settlement must still be approved by the Court. The case is being handled by CPM attorney Justin Berger, Emanuel Townsend and paralegal Caitlin McDonough, along with co-counsel Housing and Economic Rights Advocates (HERA).



Medical Laboratory Cases Move Towards Trial - Florida - U.S. District Court -

CPM attorneys Niall McCarthy, Justin Berger, and paralegal Mallory Barr are working intensively with the Florida Attorney General's office to prosecute Medicaid overbilling claims against Quest Diagnostics and Laboratory Corporation of America, the two largest medical laboratories in the country. CPM and cocounsel Matt Schultz have taken dozens of depositions in the case in recent months around the country.

MASS INJURIES UPDATES



PG&E Being Held Accountable for Destroying Homes in Calaveras and Amador Counties - Calaveras County Superior Court -

Approximately one year ago, CPM filed a lawsuit against PG&E for damages suffered by residents in Calaveras and Amador Counties resulting from the Butte Wildfire, which ignited after a PG&E electrical power line came in contact with a neighboring tree that had been trimmed in a hazardous manner and not in accordance with the standards of practice in the industry. The fire burned 70,868 acres and hundreds of people lost their homes and all of their belongings, not to

mention acres of beautiful trees and vegetation that used to surround their home. To this day, survivors are still displaced from their residences and living out of tents and trailers on the barren properties they call their home. This is another catastrophic failure by PG&E resulting from a management culture that puts profits before safety. These cases are being handled by Frank Pitre, Alison Cordova and team along with co-counsel.

Government Is Claiming No Responsibility for Kate Steinle's Death - San Francisco - U.S. District Court -

In May, CPM filed a lawsuit against the City and County of San Francisco ("CCSF"), ex-CCSF Sheriff Ross Mirkarimi, and the United States Government for the death of Kate Steinle, who was shot and killed on July 1, 2015 by an undocumented criminal with a government-issued handgun. The undocumented criminal was also in CCSF custody before being released onto the streets of San Francisco without any notice given to ICE. CPM has alleged that each government entity failed Kate. If any of them had acted with ordinary care and followed their mandatory obligations under the law, then Kate would still be alive. Each government entity disagrees and has filed a motion to dismiss the case. The case is being handled by Frank Pitre, Alison Cordova and team.



Massive Gas Leak at Southern California Gas Company's Storage Facility **Porter Ranch Threatens Residents and Property Values** - Los Angeles County Superior Court -

CPM and Kabateck, Brown & Kelner represent over 300 residents in the Porter Ranch area of Southern California who are suffering various ill health effects as well as potentially severe loss of home values as a result of one of the most massive man-made environmental disasters since the BP oil Spill in the Gulf of Mexico. Southern California Gas Company acknowledged the leak in late October of 2015 although evidence exists that the company knew the storage well was leaking years before but failed to do anything about it, indicating a clear lack of concern for the safety, health and well-being of the surrounding community and environment. The leak spewed Methane, Mercaptan, Benzene and other potentially toxic gases. Frank Pitre, Robert Hutchinson and Julie Fieber are representing residents and their families who suffer from difficulty with breathing, dizziness, nose bleeds and nausea. The long-term consequences are unknown and many residents are reluctant to move back into their homes even though the Gas Company has declared the area to be safe.

Fake Spinal Implant Cases Move Ahead With New Criminal Indictments - Los Angeles Doctors Indicted - Los Angeles County Superior Court -

CPM filed the initial claims against a group of hospitals and doctors who conspired to pay and accept illegal kickbacks for bringing spinal surgery patients to designated hospitals. CPM represents over 200 victims of the scheme, developed by the hospital defendants to pay illegal kickbacks to doctors to increase the hospitals' patient traffic. To fund the illegal scheme the hospitals artificially inflated the cost of spinal implantable hardware which they then billed to worker's compensation carriers. Michael Drobot, owner of Pacific Hospital of Long Beach, admitted in a plea agreement with the United States to overbilling more than \$500 Million over an 8-year period. As part of the conspiracy, a supplier of spinal hardware recruited a machine shop in Temecula, California, to produce counterfeit medical hardware. As a result, thousands of patients received defective, adulterated hardware causing many to suffer severe health problems. CPM is also pursuing False Claims cases on behalf of the State of California. The cases are being handled by Frank Pitre, Robert Hutchinson, Alison Cordova and team.

ANTITRUST & BUSINESS FRAUD UPDATES



\$224 Million Settlement of Price-Fixing Claims for U.S. Consumers and Businesses in Auto Parts Litigation - Michighan - U.S. District Court -

CPM's Steve Williams and his team who serves as co-lead counsel for consumers and businesses settled with DENSO Corp. and its affiliates ("DENSO") for more than \$224 million in *In re Automotive Parts Antitrust Litigation ("Auto Parts")*, a class action pending in the United States District Court for

the Eastern District of Michigan. The auto parts antitrust case stems from an alleged long-running, international conspiracy involving price-fixing, bid-rigging, and market allocation, and this is the largest settlement in the civil litigation thus far. Auto Parts involves allegations that the leading global automotive suppliers engaged in a decade-plus conspiracy to rig bids and to fix the prices of automotive parts sold to vehicle manufacturers.

Price Fixing of Domestic Air Travel - Washington, D.C. - U.S. District Court -

CPM was appointed co-lead counsel in a case alleging that defendants have illegally colluded to fix, raise, and maintain the price of domestic air passenger transportation through various means, including by eliminating or restricting the supply of domestic air transportation – otherwise known as seating "capacity." Plaintiffs filed a Consolidated Complaint in March 2016. Motions to dismiss have been fully briefed. The case is pending Washington, D.C. The case is being handled by **Steve Williams, Elizabeth Tran, Joyce Chang and team**.





Price Fixing of Resistors for Electronic Equipment - San Francisco - U.S. District Court -

CPM as lead counsel for a class of indirect purchasers of resistors purchased from defendants who allegedly conspired to unlawfully inflate, fix, raise, maintain or artificially stabilize prices. This case is pending in the Northern District of California. CPM plaintiffs have filed a Consolidated Complaint, and have begun discovery. The case is being handled by **Steve Williams, Elizabeth Tran, Demetrius Lambrinos, Joyce Chang and team.**

Transpacific - Price Fixing of Tickets - San Francisco - U.S. District Court -

CPM has reached several settlements in this case, totaling approximately \$39 million. This case, pending in the United States District Court in San Francisco, involves a global conspiracy to increase the price charged to people traveling by air between the United States and Asia. The 9th Circuit is holding a hearing on important issues concerning the power of the federal courts to adjudicate price-fixing conduct in the air transportation industry, which CPM will argue in 2017. The case is being handled by **Joe Cotchett, Steve Williams, Adam Zapala and team**.





Price Fixing of Capacitors Used in Electronic Devices - San Francisco - U.S. District Court -

CPM is Lead Counsel and represents indirect purchasers of capacitors against defendants, the leading manufacturers of capacitors sold in the United States, for engaging in two separate conspiracies to unlawfully inflate, fix, raise, maintain or artificially stabilize the prices of electrolytic and film capacitors. Defendants are located in the United States and abroad. This case has been heavily litigated through

motions to dismiss and motions for summary judgment. Settlements have been reached with three defendants and more defendants are expected to settle rather than face a trial before a jury. The case is being handled by **Joe Cotchett, Steve Williams, Elizabeth Tran and Joyce Chang**.

CPM Prevails On Ownership of WWII Tanks - San Mateo County Superior Court

In 2014, Vulcan Warbirds purchased a World War II German Panzer IV Tank. The Tank was a prominent feature of the world famous Littlefield Collection of military vehicles in Portola Valley, CA. Yet, after Vulcan paid the funds, the seller experienced seller's remorse and refused to allow Vulcan to pick up the


Tank. CPM first obtained a preliminary injunction preventing the seller from moving the Tank. In The Tank case went to trial in July 2016. CPM obtained a judgment, determining it was entitled to Alexandra Summer immediate possession of the Tank. The case was tried by **Phil Gregory and team**.

> Children's Trust - Climate Change - Oregon - U.S. District Court CPM brought a landmark case seeking to require federal officials to drastically reduce car-









In September 2016, lawyers representing the federal government and the largest energy companies in the world argued to dismiss CPM's lawsuit. U.S. District Judge Ann Aiken heard arguments about whether the plaintiffs presented valid legal claims that could be decided in court. The hearing was streamed live throughout Oregon and Washington. From the bench, Judge Ann Aiken: "Who will speak for the children?" In response, the government attorney stood at the lectern, silent. CPM attorney **Phil Gregory and his team** are handling the case.

Restoring Public Access to Martin's Beach and California Coast - California Appellate Court -

After CPM prevailed at trial in 2014 on behalf of Surfrider Foundation and the public in its lawsuit to restore access to Martin's Beach in Half Moon Bay, the defendants appealed. The briefing in the appellate court is now complete. The State of California, San Mateo County and Stanford Law School's Environmental Law Clinic each filed briefs in support of CPM and Surfrider. The parties are awaiting an oral argument date at the appellate court, and CPM continues to work on behalf of the public to protect beach access. This case is being handled by Joe Cotchett, Eric Buescher and Pete McCloskey.




Nancy Fineman, Brian Danitz and team with co-counsel represent investors who were induced to invest in real estate securities and properties based upon allegedly false promises by Benjamin Kirk and his co-conspirator, Lucy Gao, through their company Liberty Asset Management Corporation. The complaint alleges that the defendants, through a complex web of corporations and limited liability companies owned and controlled by Kirk and Gao, victimized scores of investors for their own personal profit. CPM has defeated motions to dismiss and will be proceeding to trial on


claims for securities fraud, RICO, and state law claims in the Summer of 2017.

JD Brothers Business Fraud - San Francisco - U.S. District Court -

Derivative Litigation Against Directors of Apple - Santa Clara County Superior Court -

Joe Cotchett, Nancy Fineman, Mark Molumphy and team along with co-counsel are suing officers and directors of Apple alleging that they breached their fiduciary duties to the Company and shareholders by illegally entering into agreements with other Silicon Valley companies that they would not hire from each other's companies. The directors' and officers' actions resulted in a settlement with the Department of Justice and significant payment to the employees harmed by these actions. The defendants have argued that shareholders do not have the right to sue because that right only belongs to the corporation. CPM has demonstrated that the directors are conflicted because of their knowledge of and/or participation in this scheme and, therefore, the shareholders have a right to bring this derivative lawsuit. The trial court has agreed with CPM and this case will now move forward on the merits.


