



Frank Pitre Named to Committee to Lead Nationwide Class Litigation Against Volkswagen for Emission Scandal

U.S. District Court Judge Charles Breyer in San Francisco, who was selected to oversee nationwide lawsuits against the German Automaker Volkswagen, appointed **Frank Pitre** of **CPM** to a committee of the top lawyers in the country to prosecute Nationwide Class Action Litigation for Losses suffered by consumers who unwittingly purchased certain models of Volkswagen, Audi and Porsche vehicles that the manufacturer equipped with devices designed to circumvent emissions standards. CPM represents two **Stanford** professors who brought one of the first suits. Pitre has been named one of the leading trial lawyers in the country.



Steve Williams Appointed Co-Lead Counsel in Washington, D.C. for Domestic Airline Travel Price-Fixing of Tickets

The District Court in Washington, D.C. appointed CPM's **Steve Williams** as one of two lawyers to lead the Multidistrict Litigation against numerous domestic airlines for alleged price-fixing of fares in the United States. The case alleges certain airlines have illegally colluded to fix and raise the price of domestic air passenger transportation across the nation.

Pete N. McCloskey, Jr. was honored with the prestigious **Lufkin Prize for Environmental Leadership** by the **National Audubon Society** in New York. He led environmental laws such as the **Endangered Species Act**. Pete handles major environmental cases with dedicated young CPM associates. A Stanford Law graduate, he is a recipient of the Navy Cross, Silver Star and two Purple Hearts for serving as a U.S. Marine Officer in Korea. He is one of the country's great trial lawyers and continues to lead from the front on the environment. California Indian Tribes Take Caltrans to Court For Knowingly Destroying Historic Preservation Sites in Northern California

CPM represents the Coyote Valley Band of Pomo Indians and the Round Valley Indian Tribes in a federal lawsuit against the California Department of Transportation, the Federal Department of Transportation and the Federal Highway Administration for failing to properly identify, avoid, and protect over 30 ancestral village sites in the Caltrans Willits Bypass Project. This lawsuit will establish an important state-wide precedent to challenge Caltrans' unilateral authority to determine how ancestral Native American cultural sites will be deemed worthy of protection without taking into consideration the concerns of the lineal descendants of the Tribe that historically created such sites. CPM's **Phil Gregory, Camilo Artiga-Purcell** and **Pete McCloskey** are handling the case.





In Los Angeles CPM Files Suit Against San Juan Capistrano for Illegally Collecting Millions in False Water Charges from Residents

CPM filed suit in January 2016 against the City of San Juan Capistrano for its attempt to keep millions of dollars in illegally collected water charges. In 2015, the city's tiered water rates were deemed to violate Proposition 218, which requires that government fees match the actual costs incurred in providing services. Instead of refunding the city's water customers the full amount of the illegally collected money, the city offered a refund of less than 25%. CPM's suit seeks a **full refund** for the amounts charged by the City to all of the rate payers and to hold the city accountable for its unconstitutional conduct. This case is being handled by **Niall McCarthy** and **Eric Buescher**.

Restoring Public Access to Martin's Beach - Constitutional Challenge -To Protect the California Coast

CPM's litigation on behalf of the public and Surfrider Foundation to restore public access to Martin's Beach and to enforce the California Coastal Act is on appeal. CPM is urging the Court of Appeal to uphold the trial court's decision to enforce beach access. CPM continues to work to stop efforts to restrict public access to public beaches all over California. This case is being handled by **Joe Cotchett**, **Eric Buescher**, **Pete McCloskey** and many dedicated law clerks.



CPM Files Suit to Fight Eviction for 97 Year Old



CPM's **Nanci Nishimura** and **Nancy Fineman** filed a lawsuit on behalf of 97 year old Marie Hatch to protect her legal right to stay in the house where she has lived for over 60 years. She was promised she could live in the house for life based

upon a contract but instead eviction proceedings were started against Hatch. Word of her eviction along with her roommate of 32 years, Georgia Rothrock from their cottage in Burlingame has galvanized community support with offers of help from around the world. Unfortunately, Hatch passed away on March 3, 2016. The case was covered world-wide and represents the tip of the iceberg in gentrification evictions as a form of elder abuse. CPM will continue pursuing a lawsuit for elder abuse.

CPM Represents Investors and Files Suit Against Alibaba Following One of the Largest Initial Public Stock Offerings in the U.S. by a Foreign Company



Alibaba is China's biggest and most popular online commerce company for online shopping. Alibaba's United States headquarters are located

in San Mateo, California. In September 2014, Alibaba launched a \$25 billion initial public offering in the United States, the largest in history. A class action suit filed by CPM on behalf of Alibaba shareholders alleges that Alibaba, and its founder Jack Ma, failed to tell investors of illegal business practices that were taking place on its online platform. As alleged, Alibaba was warned just two months before its U.S. IPO by Chinese officials that its platform was being used for illegal conduct, including the sale of counterfeit goods, and that its vendors were faking transactions to make sales appear higher. The well-publicized stock that initially showed great promise – trading at nearly \$120 per share – later plummeted 50 percent nearly a year later and fell below its IPO at \$68. CPM's **Mark Molumphy** and **Alexandra Summer** serve as co-lead counsel in the class action.

FALSE CLAIMS & ELDER ABUSE UPDATES



Whistleblower Case Against British Petroleum on Behalf of California Cities and Counties


Natural gas experts have been retained in the case against BP (formerly British Petroleum), and depositions are ongoing in Houston and Sacramento. **California Attorney General Kamala Harris's** office joined the case and accuses the oil company of overcharging millions of dollars to California cities, counties, universities, and government agencies on natural gas purchases over the past decade. CPM's **Niall McCarthy**, **Justin Berger** and **Emanuel Townsend** are leading the case with cocounsel Jeff Steidley of Houston.

Whistleblower Case Against Walgreens Pharmacy Set for Trial

Trial has been set for October 2016 in a qui tam case **CPM** has brought on behalf of whistleblower Michael Irwin, against the Walgreens chain of pharmacies. The case alleges that Walgreens mailed unnecessary prescription medications to patients without their consent or request, and billed the Medicare and Medi-Cal programs for those prescriptions. The case also alleges that Walgreens billed Medicare and Medi-Cal for prescription medications that were never dispensed. **Justin Berger** and **Eric Buescher** are handling the case for CPM, along with co-counsel, Gregory Brod.

Department of Education Shuts Down For-Profit College In CPM Whistleblower Case

In February, the United States Department of Education ("DOE") announced that it was cutting off federal funding to Marinello Schools of Beauty, a chain of for-profit cosmetology schools, based on allegations also asserted in a whistleblower case being handled by CPM and the Skapik Law Group. As a result, the schools have shut their doors. The case against B&H Education Inc., d/b/a Marinello Schools of Beauty, and four of its executives, alleges a multi-hundred-million dollar fraud on U.S. taxpayers through a chain of for-profit beauty schools funded through federal student financial aid programs. The case is set for trial in July 2016. **Justin Berger** and **Emanuel Townsend** are leading the case for CPM.





CPM attorneys **Niall McCarthy**, **Anne Marie Murphy** and **Eric Buescher** won a unanimous jury verdict in an elder abuse case on behalf of the family of a long-time San Francisco resident. The Court of Appeal upheld that verdict in its entirety, based on CPM's use of various different laws designed to protect seniors to prove undue influence in a variety of ways, including laws preventing caregivers from abusing their positions of authority and dependence to coerce senior citizens into "giving" them their property and estates. In March, the decision was a victory for the family.

Costco Taken to Court for Knowingly Selling Slave Labor Shrimp to Unsuspecting Californians



CPM is prosecuting a class action against Costco and CP Foods for knowingly selling farmed prawns from a supply chain that is tainted by slave labor and other human rights abuses. According to the complaint, both companies have turned a blind eye to the use of slave labor in the Southeast Asian fisheries where fishing with 'ghost ships' (undocumented vessels) is prevalent. Also prevalent is the kidnapping of workers who are then sold into debt bondage to work on fishing vessels for months or years at a time. The human rights abuses at issue in CPM's case have been the subject of global headlines and investigative reporting as well as recent criminal indictments in a similar case. This case is being handled by **Niall McCarthy** and **Anne Marie Murphy**.

MASS INJURIES UPDATES

Massive Gas Leak at Southern California Gas Company's Storage Facility Near Porter Ranch Threatens Residents and Property Values



CPM and Kabateck, Brown & Kelner represent over 300 residents in the Porter Ranch area of Southern California who are suffering various ill health effects as well as potentially severe loss of home values as a result of one of the most massive man-made environmental disasters since the BP oil Spill in the Gulf of Mexico. South-

ern California Gas Company acknowledged the leak in late October of 2015 although evidence exists that the company knew the storage well was leaking years before. The leak spewed Methane, Mercaptan, Benzene and other potentially toxic gases. **Joe Cotchett, Frank Pitre, Robert Hutchinson** and **Julie Fieber** are representing residents and their families who suffer from difficulty with breathing, dizziness, nose bleeds and nausea. The long-term consequences are unknown and many residents are reluctant to move back into their homes even though the Gas Company has declared the area to be safe.

Fake Spinal Implant Cases Move Ahead With New Criminal Indictments and Discovery in the Civil Cases -Many Los Angeles Doctors Indicted

CPM continues to pursue claims against a group of hospitals and doctors who conspired to pay and accept illegal kickbacks for bringing spinal surgery patients to designated hospitals. CPM represents over 200 victims of the scheme, developed by the hospital defendants to pay illegal kickbacks to doctors to increase the hospitals' patient traffic. To fund the illegal scheme the hospitals artificially inflated the cost of spinal implantable hardware which they then billed to worker's compensation carriers. Michael Drobot, owner of Pacific Hospital of Long Beach, admitted in a plea agreement with the United States to overbilling more than \$500 Million over an 8 year period. As part of the conspiracy, a supplier of spinal hardware recruited a machine shop in Temecula, California, to produce counterfeit medical hardware which did not meet FDA standards. As a result, thousands of patients received defective, adulterated hardware causing many to suffer severe health problems. CPM is also pursuing False Claims cases



Victory for Asiana Flight Victims Represented by CPM



On July 6, 2013, a Boeing 777 operated by Asiana Airlines crashed on the runway at San Francisco International Airport. CPM represented 14 of the passengers injured during the crash and **Frank Pitre** was named as the Plaintiffs' liaison counsel. After two and a half years of litigation, all of the claims brought by our clients were successfully resolved through the hard work of **Alison Cordova, Stewart Pollock**, and **Ryan Manuel**.

PG&E Under Fire Again for Failure to Maintain Employee Safety in San Francisco



In March, **CPM** filed a lawsuit against PG&E and Central Moloney, Inc. for injuries suffered by individuals who were injured when an electri-

cal transformer located in a subterranean vault exploded due to poor maintenance, repair practices, and design. This is the latest in a long string of incidents involving PG&E's egregious failure to maintain its energy transmission systems in a safe manner. CPM attorneys **Frank Pitre** and **Stewart Pollock** are leading the case.

Status of GM Ignition Switch Litigation



In March, the second bellwether trial started in the GM Ignition Switch Litigation in New York Federal District Court. The third bellwether trial for the wrongful death of James Yingling, is scheduled to start in May. The new GM - now out of bankruptcy - filed a Motion to Dismiss Claims of Certain Economic Loss Plaintiffs. Attorneys **Frank Pitre**, **Stewart Pollock** and **Alison Cordova** are handling the case for CPM along with co-counsel around the U.S.

Fracking Activities in San Joaquin Valley




CPM continues to file cases on behalf of farmers whose crops have been destroyed due to the release of waste products from fracking ac-

Litigation For Monster Against Beats Electronics Headed to Trial in Los Angeles



CPM's litigation on behalf of Monster, LLC and its CEO, Noel Lee, alleging fraud-based claims against Beats Electronics, HTC and others was transferred to Los Angeles County Superior Court. The jury is set for September 6, 2016. The Complaint states that, "af-

ter defendants improperly took control of the 'Beats By Dr. Dre' products, they severed all ties with Monster and Lee and then sold the Beats brand to Apple for \$3.2 billion as the defendants made millions and the Plaintiffs lost millions." Monster and Lee are represented by CPM's **Joe Cotchett**, **Phil Gregory**, **Nanci Nishimura** and **Brian Danitz**.

CPM's Commitment to Pro Bono Work



The Federal Court appointed **Joe Cotchett** and **Elizabeth Tran** as pro bono counsel for an inmate through the Federal Pro Bono Project. They represented a second-degree murderer who alleged a vio-

lation of civil rights under the Eighth Amendment, which confers basic rights to even the most chronic and hardened inmates and prohibits cruel and unusual punishment. The case was settled with the State of California two weeks before trial in Federal Court.

Capacitors Price-Fixing Litigation San Francisco



CPM is Lead Counsel and represents indirect purchasers of capacitors against defendants, the leading manufacturers of capacitors sold in the United States, for

engaging in two massive and separate conspiracies to unlawfully inflate, fix, raise, maintain or artificially stabilize the prices of electrolytic and film capacitors. Defendants are located in the United States and abroad. This case has been heavily litigated through Motions to Dismiss and Motions for Summary Judgment. Indirect purchaser plaintiffs will file for class certification this year.

Auto Parts Price-Fixing Litigation



This case involves a massive conspiracy to fix prices for component parts of cars. The complaint alleges that these increased prices are then passed on to consumers who purchase motor vehicles. The first settlements have been announced with defendants TRW, Yazaki, Nippon Seiki, Autoliv, Lear, Hitachi, and Panasonic. The Court has also upheld complaints in the Wire Harness, Fuel Senders, Heating Control Panel, and Bearings cases, and discovery is beginning. Thus far, at least 29 separate auto parts have been identified as being the subject of price-fixing by defendants. The United States Department of Justice has called this conspiracy the "biggest criminal antitrust investigation that we've ever encountered . . . with respect to the impact on U.S. businesses and consumers." Steve Williams leads his team in Detroit.

Freight Forwarders Price-Fixing Litigation New York



CPM is Co-Lead Counsel for a class of businesses and individuals that purchased shipping services from freight forwarders like DHL, UPS, Kuehne + Nagel and many others.

After several years of intensely fought litigation, CPM and cocounsel have reached settlements with many defendants that will result in a recovery for the Class of over \$350 million. That amount will grow as several defendants make additional payments under their settlement agreements.

Ogaz v. The City of Milpitas – San Francisco

CPM represents the former City Attorney for the City of Milpitas in an important unlawful termination case. The complaint alleges that the City unlawfully retaliated against Mr. Ogaz for his participation in an investigation into potentially discriminatory and unethical conduct by Milpitas's City Manager.

Resistors Price-Fixing Litigation - San Jose

The Court appointed CPM as sole Lead Counsel on behalf of a plaintiff class of indirect purchasers of resistors purchased from defendants who allegedly conspired to unlawfully inflate, fix, raise, maintain or artificially stabilize prices. This case is pending in the Northern District of California before Judge Ronald M. Whyte, and is also being investigated by the Department of Justice. Indirect purchaser plaintiffs will file a Consolidated Complaint this year.

Transpacific Air Transportation Price-Fixing Litigation - San Francisco

CPM recently announced several settlements in this case, totaling approximately \$39 million. This case, pending in the United States District Court in San Francisco, involves a global conspiracy to increase the price charged to people traveling by air between the United States and Asia.

Archdiocese Employees Litigation – San Francisco

CPM has filed a class action complaint against the Archdiocese of San Francisco on behalf of its teachers, janitors and other employees for underpaying required health care contributions mandated by an innovative San Francisco ordinance, the Health Care Security Ordinance.

Foreign Antitrust Cases - Europe and Far East

CPM is reviewing several new antitrust cases coming out of the European Union and the Far East. CPM has been working on the legal aspects of these cases through London and Shanghai law firms.

Big Victory for California Cities and Counties in Municipal Bond Insurance Litigation Against Rating Agency and Bond Insurers

Nanci Nishimura and her team obtained a major victory in the Municipal Bond Insurance Litigation for California cities, counties and public agencies. The Court of Appeal revived antitrust claims by 26 public entities against bond insurance companies, in a case alleging the bond insurers colluded to require public entities to buy unnecessary insurance before issuing bonds to raise money for public projects. The Court of Appeal also affirmed that credit rating agency Standard & Poor's can be sued for unfair business practices and negligently misrepresenting the bond insurers' credit ratings relied on by public entities. When the bond insurers' credit ratings were downgraded -- depicted in the financial crisis movie The Big Short – the public entities' bonds became unmarketable, costing them multi-millions of dollars in unnecessary premiums, interest payments and penalties.

Emergency Road Service Providers Seek Relief Against AAA for Labor Practices

CPM has a long history of representing the interests of labor and employees. When businesses do not classify or treat employees fairly, not only is the individual employee hurt, but our system is corrupted. Despite providing 95% of the emergency road service for AAA members in Northern California, those who come to your aid are not, according to AAA, employees of AAA, but, instead independent contractors. The service providers in California are challenging AAA's position. The lead attorneys are Matt Edling and Stephanie Biehl.

Hundreds Pack Oregon Courthouse To Support Youth In Landmark Constitutional Climate Change Case



In March, the Federal District Court in Eugene, OR, heard oral argument in the landmark constitutional climate change case brought against the federal government. All 21 young Plaintiffs, ages 8-19, from across the U.S. and Dr. James Hansen attended the hearing. Hundreds of students, professors, and citizens concerned about climate turned out in Eugene and Portland, OR to support the 21 young plaintiffs in what Bill McKibben and Naomi Klein call the "most important lawsuit on the planet right now." Plaintiffs sued the federal government for violating their constitutional rights to life, liberty and property by permitting, encouraging, and otherwise enabling continued exploitation, production, and combustion of fossil fuels. Phil Gregory is handling the case for CPM.

Royalty Owners Test How Far Oil Companies Can Go

CPM along with the Ernst Law Group ("ELG") represent land owners in California who have contracted with Chevron to allow for oil exploration on their land in exchange for a share of the oil royalties. On behalf of their clients, CPM and ELG have filed their motion for class certification in San Luis Obispo Superior Court asserting that Chevron improperly calculates the market value of the oil extracted from the land and takes improper deductions prior to compensating royalty owners. The lead attorney from CPM is Matt Edling and his team. If you are a royalty owner, CPM encourages you to check with your CPA or trusted advisor to ensure that the royalties you receive are accurately accounted for and comply with your contract.

CPM Prepares Backhouse Embezzlement Litigation for Trial Ponzi Schemes Are Now Flourishing

CPM represents trustees that fell victim to a massive fraud resulting in losses of millions of dollars. The Complaint alleges Leo Joshua Kennedy, assisted by Heritage Bank of Commerce, misappropriated Plaintiffs' hard-earned funds and spent them on a lavish lifestyle, speculative startups that went bust, and first-class travel, including pre-paid vacations and limousine service for Heritage bankers. Plaintiffs are left facing a nightmare of epic proportions: Kennedy and the entities he utilized to control Plaintiffs' trust funds are out of business, and Plaintiffs' trust funds are lost. CPM attorneys Phil Gregory and Camilo Artiga-Purcell defeated Heritage Bank's motion for summary judgment, and are set to try the case in January 2017 in San Jose.
