WILLIAMS APPOINTED TO CALIFORNIA COURT CASE MANAGEMENT SYSTEM COMMITTEE

Steve Williams has been appointed by the Judicial Council of California to the California Court Case Management System Justice Partner Advisory Committee. The Committee will advise and make recommendations concerning statewide policies, business practices, and standardization relating to the deployment of an electronic court case management system used in all trial courts. Williams served as part of a Judicial Council Committee responsible for the drafting of California's e-discovery laws.



EDLING APPOINTED BOARD OF HAMILTON FAMILY CENTER

In January, Matt Edling was appointed to the Board of the Hamilton Family Center. Hamilton Family Center is the largest provider of shelter, eviction prevention assistance, rapid re-housing, youth programming, and support services for homeless families in San Francisco.

CPM STOPS THE SALE OF THE CALIFORNIA SUPREME COURT BUILDING, THE RONALD REAGAN BUILDING AND OTHER STATE BUILDINGS



Joe Cotchett, Anne Marie Murphy and Eric Buescher represent two former members of the Los Angeles State Building Authority in litigation to halt the fire sale of eleven iconic state-owned facilities, including the San Francisco Civic Center Buildings and the Ronald Reagan State Building in Los Ange-

les. The lawsuit alleged that the \$2.3 billion sale to a private consortium with roots in Mumbai, India and Texas was both **illegal and unconstitutional**. According to the suit, the sale was hatched out of <u>last</u> <u>minute</u> efforts by the Schwarzenegger Administration to "allegedly" close the recent budget shortfall. The independent analysis of the **Legislative Analyst's Office** said the deal would cost future generations of Californians nearly \$10 billion in exchange for present day savings of barely one-tenth that amount. Plain-tiffs obtained an important victory at the appellate court level when the 6th District Court of Appeals

stopped the sale. Newly-elected Governor Brown reconsidered the transaction and on <u>February 9, 2011</u> he **announced that the sale would not occur.** He noted that the transaction would have cost taxpayers \$6 billion, which was a **primary argument** in the case filed by CPM. The lawsuit has been the subject of investigative reporting by dozens of newspapers including *The Los Angeles Times* and *The New York Times*.

JURY HOLDS FORMER CEO OF HOMESTORE.COM LIABLE FOR THE LOSSES TO THE CALIFORNIA STATE TEACHERS' RETIREMENT FUND



A Los Angeles Federal jury awarded the California State Teachers' Retirement System (CalSTRS) and other investors a **multi-million dollar security fraud judgment** against the former CEO of Homestore. com. The jury found Stuart H. Wolff, the former chief executive officer and chairman of the board of Homestore, liable for damages while heading the company. The jury found that the CEO was responsible for the actions of other senior executives who engaged in a fraudulent



scheme where Homestore created a circular flow of money, known as "purchased revenues" in which money flowed from Homestore to outside firms and back to Homestore. After the fraud was uncovered, Homestore was forced to restate more than \$120 million in revenue. The securities fraud case, one of the few brought to trial, was headed by **Nancy Fineman**, and with her was **Daniel Sterrett**. CalSTRS had previously settled with other Homestore executives and with the company's auditor, PricewaterhouseCoopers. CalSTRS is the second largest pension fund in the U.S. CPM has represented CalSTRS for many years.

CPM APPOINTED CO-LEAD COUNSEL IN BRITISH PETROLEUM SECURITIES GULF CASE BY FEDERAL COURT IN HOUSTON - TEXAS

On December 28, 2010, Judge Keith P. Ellison of the Southern District of Texas appointed **CPM** and **Richard Mithoff** of Houston as Co-Lead Counsel for investors of BP securities during the period of March 4, 2009 to April 20, 2010. **CPM** alleges that BP touted its unique ability to conduct deep sea oil drilling operations in high-risk environments such as the Gulf of Mexico. BP, however, **concealed internal warnings** about its Gulf operations and failed to implement appropriate safety protocols in order to keep costs down. These misrepresentations

were discovered after the explosion of the Deepwater Horizon. **CPM and Mithoff** were appointed to serve as Lead Counsel for investors because their interests were potentially in conflict with the pension funds for New York and Ohio, who were appointed to represent a longer class period. **Joe Cotchett**, **Mark Molumphy** and **Richard Mithoff** are the lead attorneys representing this group of BP shareholders and lead a team of attorneys that include **Matthew Edling**, **Jordanna Thigpen**, **Imtiaz Siddiqui** and **Bryan Payne**. CPM is honored to work with Richard Mithoff on this important case.

CPM WINS ARBITRATION AWARD AGAINST WALL STREET BROKER

Steve Williams and Aron Liang won a \$3 million award against investment advisory firm, Wedbush Morgan, in a FINRA arbitration in Seattle, Washington. This lawsuit, brought on behalf of aggrieved investors, involved Wedbush Morgan's wrongful recommendation to invest in Nuveen Auction Rate Preferred Securities ("ARPS"), an investment vehicle that imploded in February of 2008. When the ARPS market crashed in February of 2008, almost \$300 billion became frozen, leaving millions of investors unable to access their own money. Many investors were injured by the collapse of the ARS market and CPM was one of the first law firms to investigate the problem and take cases to trial. CPM has long been a leading advocate for Main Street investors who have been deceived by Wall Street firms and major corporations.

COTCHETT RECEIVES AWARD FROM SAN MATEO CHAMBER OF COMMERCE



In February, the San Mateo Area Chamber of Commerce and the City of San Mateo presented Joe Cotchett with the Frances Bohannon Nelson Legacy Award. The commemoration took place at the 16th Annual Business Awards Dinner where Hon. Jackie

Speier and **Hon. Anna Eshoo** were in attendance to honor Cotchett. Cotchett received the award for his dedication and involvement with the community, his pro bono work and his efforts to make a change in society in San Mateo County.

LOCAL BAY AREA FISHERMEN RECOVER MILLIONS AFTER OIL SPILL BY OIL TANKER IN BAY

Through a class action, **\$6 million** has now been returned to local fishermen in the aftermath of the November 7, 2007 Cosco Busan oil spill. About 120 commercial fishermen will share in the settlement. **Frank Pitre** led the CPM lawyers, which resulted in the award to fishermen.

JURY AWARDS \$800,000 TO PENINSULA RESIDENT



Jordanna Thigpen secured an award of \$800,000 on behalf of a local resident who was victimized by a Ponzi scheme targeting senior citizens. "We hope that the jury's

verdict sends the message loud and clear to people that they can't take senior citizen's money without consequences," Thigpen said.

MORE MUNICIPALITIES SUE WALL STREET



Nanci Nishimura is leading the charge against 40 major banks, insurance companies and brokers that provided guaranteed investment contracts and swaps to cities, California

counties, and other agencies. In the federal government's criminal investigation, Bank of America admitted that the bidding process for obtaining these municipal derivatives was rigged. Recent complaints filed by CPM, the Los Angeles Unified School District and New York state entities, now totals 24 entities taking on Wall Street.

HISTORIC SETTLEMENT IN ELDER ABUSE -LEGAL AID SOCIETY PRAISES OKCU



Lead attorney, **Niki Okcu**, along with **Hope Nakamura** of Legal Aid Society of San Mateo County handled the elder abuse case *pro bono*, which involved the bilking of an **89 year old widow**, **Pauline Reade**, out of nearly \$600,000. Ms. Reade faced foreclosure on the Pacifica home she has lived in since 1951 after Fetuu Tupoufutuna, a scam contractor, tricked her into signing loan documents in the

sum of hundreds of thousands of dollars with various banks and mortgage entities. The settlement comprised that the lien on Ms. Reade's property will be completely removed and she will have no obligation under the loan which currently exceeds \$420,000.

FINANCIAL ELDER ABUSE SETTLEMENTS



Justin Berger successfully resolved several financial elder abuse cases in recent months, including the case of *Berry v. Ibrahim*, in which Berger secured over \$200,000 for an elderly Stockton couple that had been sold an unsuitable life insurance product. This is one of many cases where senior citizens are victims of fraud.

CASE UPDATE: SAN BRUNO PIPELINE EXPLOSION FRANK PITRE -- ARA JABAGCHOURIAN -- NIKI OKCU

On September 9, 2010, a pipeline owned and operated by PG&E ruptured below the Crestmoor neighborhood of San Bruno, killing eight, injuring many more, and destroying more than three-dozen homes. Early reports from the National Transportation Safety Board and others charged with investigating the disaster have revealed disturbing details about PG&E's maintenance and inspection of the pipe. For example, the NTSB found that the pipe that exploded contained welding "imperfections," and PG&E has come under fire in the wake of the disaster for being unable to locate key records and information relating to the ill-fated pipe. As NTSB chairwoman Deborah Hersman summed it up, "In the years since the pipe was put into service, decisions regarding inspections, operating pressures and risk management plans were all based on facts that were just plain wrong." CPM represents over forty-five families and individuals who lost loved ones or were injured in the fire, or whose homes were destroyed or damaged in the blaze.
