## SUPREME COURT LEAD PAINT DECISION LEVELS PLAYING FIELD FOR CALIFORNIA CITIES AND COUNTIES

On July 26, 2010, the California State Supreme Court issued a decision in a lawsuit filed by Santa Clara County and joined by other cities and counties against the lead paint industry. The court ruled that local governments can hire **Cotchett**, **Pitre & McCarthy** and others under contingency fee arrangements to pursue lawsuits under California's public nuisance laws. **Frank Pitre** said, "**The Supreme Court's decision assures a level playing field when our local government utilizes the civil justice system to protect the**

The decision is particularly important in light of recent revelations of how Wall Street raided the treasuries of state and local governments with a plethora of investment products touted as safe and secure, but in actuality were known to be junk. Nancy Fineman said, "The opinion reaffirms the right of public entities to hire private counsel on a contingent fee basis to provide their expertise and experience in assisting public entities in remedying these wrongs." Pitre received his BS and law degree from the University of San Francisco. Fineman received her BA from UC Berkeley and law degree from Boalt Hall School of Law.

# SAN BRUNO PIPELINE EXPLOSION CASES FILED AGAINST PG&E



**Frank Pitre**, **Ara Jabagchourian** and **Niki Okcu** represent nearly **three dozen families** against PG&E as the victims of the San Bruno pipeline explosion which occurred on September 9, 2010. Many of the victims lost family members, were severely burned, lost their homes, or had extensive damage to their homes. The natural gas-fed explosion carved a huge crater and sent flames shooting 85 feet into the air. The fire killed eight people and injured dozens more, and destroyed or damaged several dozen homes. More than 100 residents were evacuated from the 10-acre fire to emergency shelters and nearby hospitals.



The San Bruno blast was the second in two years involving a PG&E gas line in Northern California to cause death and injury, and came days after the utility received several reports of natural gas odors from residents but failed to respond. The lawsuits accuse PG&E of negligence, nuisance, and other claims. The complaints allege that PG&E is responsible for more than 58 significant natural gas leaks and resulting property damage of millions of dollars in California since 2002, according to US government statistics compiled by the Pipeline Safety Trust, a nonprofit advocacy group in Bellingham, Washington. Those incidents include a Christmas Eve 2008 rupture in the Sacramento suburb of Rancho Cordova that killed one man and injured two other people, according to the Pipeline Safety Trust. The 2008 blast occurred months after state regulators cited PG&E for failing to adequately train its workers to recognize potentially dangerous leaks. More than 60 percent of natural gas lines are 40 years or older and lack anti-corrosion coatings that could have prevented the degradation that led to pipeline failures and explosions, the Trust said in a recent analysis.

She was voted as one of the top 100 women lawyers in California for 2010. She was also recently re-elected to continue as the District 3 Governor serving San Mateo, Alameda, Santa Clara, and Contra Costa Counties and is also chair

of **CWL's International Committee**. CWL is the only statewide bar association for women in the State that promotes the advancement of women in the legal profession and actively advocates for the concerns of women in society. Since 1974, CWL has advanced the interests of more than **30,000 women** in all facets of the law, including lawyers, students, educators, legislators, and judges. Nanci received a BA and Masters from USC and a law degree from the Columbus School of Law at the Catholic University in Washington, D.C.

# EDLING FINALIST FOR STREET FIGHTER BY CONSUMER ATTORNEYS OF CALIFORNIA



**Matt Edling** was selected as a finalist for the 2010 Street Fighter of the Year Award by the Consumer Attorneys of California ("CAOC") for his work on behalf of an elderly investor placed into unsuitable investments. A FINRA panel awarded Edling's 87 year old client a substantial recovery finding that a large financial institution's behavior was negligent

and that its financial advisors breached their fiduciary duties to Edling's client. He will be honored at CAOC's Annual Installation Dinner this November in San Francisco. Edling is a graduate of Cal Poly and UC Hastings Law School.

# MONTANA POWER LITIGATION

In September 2010, litigation involving the collapse in 2003 of Montana Power Company, once Montana's largest company, finally ended with the payment by numerous defendants of over \$100 million. Joseph Cotchett and Nancy Fineman, along with Montana attorney Mark Baker, represented the bankruptcy trustee of Montana Power's successor. In an action litigated in Montana federal court, they filed suit against Gold-man Sachs and Milbank Tweed for their part in the company's collapse. Joe Cotchett said, "Corporate greed rather than sound business decisions transformed Montana Power from a successful utility company to a bankrupt telecommunications company. This case should be a lesson to decision makers who put Wall Street's values ahead of the values of Main Street."

#### CALIFORNIA COUNTIES AND CITIES BENEFIT FROM RULING BY WASHINGTON FEDERAL JUDGE

In October, a federal judge in Seattle rules that various counties and cities represented by **Mark Molumphy** of CPM may proceed with litigation against Washington Mutual executives and WaMu's accountant, Deloitte. The judge ruled that the cities and counties, which purchased WaMu bonds, could pursue claims under California state law based on alleged misrepresentations about WaMu's exposure to subprime loans. WaMu was taken over by JP Morgan Chase after revealing devastating losses from its subprime portfolio.

# CPM REPRESENTS RESIDENTS AGAINST STATE ON CUTTING REDWOODS IN RICHARDSON GROVE



In October, **Phil Gregory** and team filed a Federal action in San Francisco to block the state from cutting redwoods to widen a state highway through an ancient grove of redwoods. The case follows a state court case filed previously in San Francisco.



#### ARMENIAN GENOCIDE LAWSUIT ON BEHALF OF ARMENIAN VICTIMS

On July 29, 2010, **Ara Jabagchourian**, along with Los Angeles attorneys Mark Geragos and Brian Kabatek, filed a multi-million dollar class action lawsuit in the Central District of California against the Republic of Turkey on behalf of Armenians seeking compensation for confiscated properties and belongings as a result of the Genocide of 1915-1923. The lawsuit targets the Central Bank of Turkey and the Ziraat Bank as financial instruments of the Turkish Government. The complaint charges the Republic of Turkey and its predecessor, the Ottoman Empire, of "confiscating, selling and deriving income from real estate and personal property" that was owned by hundreds of thousands of Armenians who were killed during the Genocide.

## **REBUILDING FOR THE CHILDREN - PLAYGROUND IN A DAY**



On Saturday, July 31, 2010, **Cotchett, Pitre & McCarthy** attorneys, paralegals, law clerks and staff participated alongside 390 volunteers from the City of Daly City, KaBOOM!, the Foresters and the Mid-Peninsula Boys & Girls Club (MPBGC) to build a "playground in a day" which benefitted the MPBGC's Bayshore Heights clublocation. KaBOOM!, anational non-profit, is dedicated to saving play for America's children. Their mission is to create a great, safe place to play within walking distance of



every child in America. The CPM team this year was headed up by senior paralegal and MPBGC board of director member, **Darren Kelley**, attorneys **Justin Berger** and **Neil Swartzberg**, case assistant **Mallory Barr**, administrative assistant **Rey Tanada** and summer law clerk **Kyle Morishita**. Through CPM's efforts, MPBGC was the recipient of a *cy pres* award of over \$37,000 in recent years along with hours of community service.

## PLANE CRASH IN PALO ALTO FILED FOR TESLA EMPLOYEES



On February 17, 2010 a Cessna 310R took off from the Palo Alto Municipal Airport and collided with power lines, then crashed into multiple homes, narrowly missing a day care center. All three people onboard were killed. **Frank Pitre** and **Niki Okcu** represent one of the victims who was also a Tesla Engineer in the San Mateo County Superior Court lawsuit. Pitre contends

in the lawsuit, "This plane crash could have been avoided if the owner and operator of the aircraft, Douglas Bourn, demonstrated concern for the safety of his passengers - instead of blatant disregard for his lack of recent flying experience, poor weather and the condition of his aircraft." **Pitre** has previously handled numerous aviation cases such as **Alaska Airlines MDL No. 1343**, **Singapore Airlines MDL No. 1394**, **PSA Flight 1771** and numerous other fixed wing and helicopter cases.

#### BERGER & EDLING TEACH ELDER ABUSE LAW



On September 28, 2010, attorneys **Justin Berger** and **Matt Edling** spoke about the basics of elder abuse law at Ropers, Majeski, Kohn & Bentley. They spoke about handling cases involving the physical and financial abuse of elders and the new law in the area. Berger received his BA from Yale University and law degree from Boalt Hall School of Law.



# CPM RECOVERY EXCEEDS \$37 MILLION IN TECHNOLOGY CASE

A CPM team headed by **Joe Cotchett** and **Steve Williams** has successfully prosecuted an antitrust class action in the SRAM Antitrust Litigation. Plaintiffs allege that from November 1996

through December 2005, leading technology companies, including Samsung, Cypress, Toshiba and Hitachi, conspired to fix, raise and maintain the prices of SRAM, a memory chip used in a wide variety of computer and consumer electronic products. As lead counsel for the direct purchaser plaintiffs, CPM reached separate settlements with seven sets of Defendants (Etron, Hynix, ISSI, Micron, NEC, Renesas-Hitachi-Mitsubishi and Toshiba), which together total over \$37 million. These settlements were approved by the court in July 2010. The case is set for trial in early 2011.

## NATIONAL FARM INSURANCE LITIGATION

Joseph Cotchett, Nancy Fineman and Niki Okcu are working to implement an order of the federal court in Los Angeles ordering a return of an insurance company as restitution because of an erroneous breach of contract judgment against their clients. The plaintiff had executed on the judgment and took over our clients' insurance company before the appeal was decided. The Ninth Circuit Court of Appeals reversed the judgment finding that the trial court erred in submitting the case to the jury because the contract required all parties sign the agreement before it became binding and several signature lines were left blank. The parties never formed a valid contract and none of the parties could be liable under its terms. As a result, the client will be receiving their insurance company back in addition to the profits they lost and all costs.

## GROSS FIGHTS AGAINST MINING IN EL SALVADOR FOR LOCAL COMMUNITIES



**Stuart Gross** has been tapped to join a three-person team of international investment law experts organized by the Center of International Environmental Law ("CIEL") to represent La Mesa Nacional Frente a la Mineria Metalica in El Salvador (the National Working Group against Mining in El Salvador) as *amicus curiae* in two cases

brought by North American mining companies against the government of El Salvador, under the Dominican Republic Central American Free Trade Agreement ("CAFTA") at the International Center of the Settlement of Investment Disputes ("ICSID") in Washington, DC. The cases challenge the El Salvadoran government's continued authority under CAFTA to restrict mining activities in its territory based on environmental and social concerns. La Mesa represents a broad coalition of local community groups in El Salvador opposed to the expansion of mining in their country. Gross is a graduate of Wesleyan University and Michigan Law School.
