Anne Marie Murphy is a partner at Cotchett, Pitre & McCarthy, LLP, where she practices civil litigation focusing on complex commercial litigation, class actions, consumers' rights, and elder abuse (including both financial abuse and nursing home abuse). However, her litigation practice is far ranging and includes litigating against Major League Baseball over the Baseball Antitrust Exemption and representing taxpayers in a suit to stop Governor Schwarzenegger from selling major Californian historic properties and courthouses.

In 2016, 2017, 2018, and 2019, Anne Marie was named to the Super Lawyers list of the top 100 lawyers in Northern California and its list of the top 50 women lawyers. In 2017, Anne Marie was elected to Litigation Counsel of America as a Fellow. In each year since 2017, Anne Marie has been named to the Irish Legal 100. In 2015, Anne Marie was named to the Daily Journal's list of the top 100 women lawyers in California, as well as its list of the top 25 plaintiff attorneys in California.

intentional infliction of emotional distress and California Fair Debt Collection Practices Act claims, resulting in both compensatory and punitive damages awards. On appeal, several important issues of first impression were decided in the plaintiff's favor, as reflected in the published decision: *Komarova v. National Credit Acceptance, Inc.*, 175 Cal. App. 4th 324 (Cal. App. 1st Dist. 2009).

Anne Marie has practiced extensively in the area of elder abuse, handling many notable cases, including jury trials against nursing homes and those who have taken financial advantage of seniors. Anne Marie's jury trial experience also includes business disputes, real estate disputes and probate and trust matters. Anne Marie has also acted as co-lead counsel in several consumer class actions which have returned millions of dollars to consumers across the country. Anne Marie has argued before the Ninth Circuit as well as the Joint Panel on Multidistrict Litigation.

Anne Marie is a long-standing member of Consumer Attorneys of California, the American Association for Justice, the San Mateo County Bar Association, the San Mateo Trial Lawyers Association, and is a lifetime member of California Women Lawyers.

Anne Marie serves on the Board of Directors of Consumer Attorneys of California (CAOC) and has been Co-Chair of the Donald L. The Commission plays a vital role in bringing together the three branches of government, plus judges, lawyers and civic and business leaders, to find long-term solutions to the chronic lack of legal assistance available to low-income and vulnerable Californians. Anne Marie continues to serve on the CCAJ.

Anne Marie has provided frequent commentary on consumer rights issues, including binding mandatory consumer arbitration, and has appeared on local and national news broadcasts including ABC 7 On Your Side (Cable 7), View From The Bay, Ring of Fire, and Good Morning America (ABC). In addition, Anne Marie frequently lectures on trial practice, as well as substantive areas of law, including elder abuse, consumer rights and arbitration.
